Our goal in this discussion is to use real world examples to illustrate the thinking, methods, and processes of risk management. What are the risks that we face and how do they impact us? Can effective risk management help reduce our insurance costs and reduce day-to-day interruptions to our work? How can we get started? Participants will leave with lots to ponder as they consider how effective risk management can help them meet their operational objectives.
